COMPREHENSIVE PLAN UPDATE
07-19-2016

A Public Hearing of the Village of Wrightstown Board of Trustees was held on Wednesday 07/19/16 at the Village Hall, 352 High Street, and called to order at 6:00 pm by Village President Dean Erickson with the reading of the public hearing notice.

The purpose of the Public Hearing was to hear from all persons and/or their agents on the following:

The draft Comprehensive Plan Update consists of written text, graphics, and maps. The specific elements of the plan include: Issues and Opportunities; Land Use; Transportation; Economic Development; Housing; Community Facilities and Utilities; Natural, Cultural, and Agricultural Resources; Intergovernmental Cooperation; and Implementation. The plan also includes goals, objectives, and policies relating to these topics.

The draft Comprehensive Plan Update is available for review at the Wrightstown Branch of the Brown County Library, on the Village of Wrightstown website www.wrightstown.us and at the following locations: Wrightstown Village Hall; Brown County Planning Commission.

D Erickson welcomed any public input on the Comprehensive Plan Update and asked for comments from the Village Board and those in attendance.

Per D Erickson the plan will be amended at a further date to add expansion for residential growth in the Village of Wrightstown. T Coenen stated that there would be no action on adopting the Comprehensive Plan at the July 19, 2016 meeting. The board will review comments from the public and talk about updates to the plan at the August 2, 2016 Village Board meeting. Action on the Comprehensive Plan Update will take place at the August 16, 2016 meeting.

D Erickson asked a second time for comments from the Village Board and those in attendance.

K Wendlandt asked if any updates were submitted to the Clerk's office and there were none.

D Erickson asked a third and final time for public comment regarding the Comprehensive Plan that was submitted for public review by the Village Board and there were no comments.

Motion by S Byers, second by Q Cavanaugh to close the Public Hearing on the Comprehensive Plan Update. **Motion carried.** (Adjourned 6:04 pm)
